



TERMS AND CONDITIONS FOR THE USE AND REPRODUCTION OF DIGITAL IMAGES

1. All images, as they appear in Travelogues website belong to public domain. The “Aikaterini Laskaridis Foundation” is the sole and exclusive holder of all intellectual property rights of the digital images, as they are uploaded on the website.
2. The use of any digitized image, as uploaded on the website, is free of charge, subject only to the restrictions and provisions of paragraphs 3c and 5. The Foundation may provide high resolution images upon request, for a fee, depending on the purpose of use.
3. Users who wish to purchase digital images at a higher resolution than the one uploaded on the website should fill in the request form, thus agreeing to the following Terms and Conditions:
 - a. The term “image” applies to one or more images in digital form.
 - b. Upon the approval of the request form by the “Aikaterini Laskaridis Foundation”, the user is granted a non-exclusive license of use. This license applies only to the specific use described in the form submitted; the image provided is strictly personal and cannot be transferred or sublicensed to a third party, in any way.
 - c. The image shall not be copied, sold, altered, adapted, modified or in any other way exploited or processed without the explicit written consent of the “Aikaterini Laskaridis Foundation”. Any other use than the one stated at the original license shall constitute new use, for which the user must obtain a new approval from the Foundation at the appropriate additional charge.



d. The high resolution image shall be sent to the user according to the form submitted and shall not be altered in colour, size etc. Further editing of the image other than the one absolutely necessary for the designated use is forbidden.

The license applies to both electronic and analogue editions for the same image. In any other case, the reproduction in a printed or electronic publication shall be considered as additional use, for which a separate request form is required.

e. Adequate and appropriate technological measures shall be taken by the user when the image is uploaded in any digital or analogue type of medium in order to prevent copying, alteration etc. from any third party.

f. For the public sector, public and private educational institutions, scholars and students of all levels, and in general for any use of pure educational nature, the charge is 10,00 Euros per image. For any other legal entity or any other person and for any other purpose, especially for commercial use, the charge is 50,00 Euros per document.

g. Once the request form has been accepted from the "Aikaterini Laskaridis Foundation", payment shall be made as following:

- h. The user shall either collect the image from the Foundation's offices, or receive it by e-mail or by post (at his/her own charge).
 - i. The "Aikaterini Laskaridis Foundation" retains the right to dismiss a request, upon its judgment.
4. If the image is used for publication (printed or digital), the user shall grant a copy to the Foundation.
 5. All forms of publication shall give credit to the "Aikaterini Laskaridis Foundation", and shall also bear a full reference to the image, namely the library the book is located at, the collection etc., as this is shown on Travelogues website.
 6. The user shall indemnify, defend and hold harmless the Foundation from and against any claim arising out of or in connection with the use of the image from the user.
 7. Breach of any of the above clauses will constitute reason for the revocation of the granted license, which will come into effect with the notification of such notice.
 8. All differences derived from the aforementioned terms shall be governed by Greek Laws and the parties submit to the exclusive jurisdiction of Greek courts.
